FALL 2004 ENROLLMENT SUMMARY

Executive Summary

This report summarizes the status and trends in fall enrollment at the University of Missouri's four campuses. The report includes information, about enrollment, full-time equivalence, new students on campus, undergraduate transfer students, full/part-time status, resident status, and gender and ethnicity information. Highlights of the report include:

The University of Missouri System enrolled a record 62,161 students in Fall 2004, a slight increase over the record 62,089 students that enrolled in Fall 2003. Total enrollment at the University has increased by 11% over the past 5 years. (Table 1a)

In Fall 2004, the University of Missouri enrolled 46,967 undergraduate students (76% of total headcount), 2,728 first professional students (4%), and 12,466 graduate students (20%). (Table 1b)

From Fall 2003-Fall 2004, total undergraduate enrollment increased 1% from 46,321 to 46,967. Full-time equivalence at the University of Missouri System increased 2% from Fall 2003. (Table 2.0)

The University of Missouri System enrolled a total 41,797 full-time and 20,364 part-time students in Fall 2004. Seventy-three percent of all undergraduates were enrolled full-time while 39% of all graduate students were full-time. (Table 4.0)

Eighty-one percent of all students enrolled in Fall 2004 at the University of Missouri are Missouri residents. (Table 4.0).

Women comprised 54% of total enrollment in Fall 2004. UM-St. Louis had the largest percentage of women (62%) and UM-Rolla had the highest proportion of men (78%). (Table 5)

Of all the students of known ethnicity, under-represented minorities (American Indian/Alaskan Native, African-American, and Hispanic) represented 12% of the University of Missouri System's total Fall 2004 enrollment. (Table 5)

Technical Notes

These tables provide counts of students enrolled in Fall 2004 on-schedule credit courses at the four campuses of the University of Missouri. Information from other fall enrollments are included for comparison purposes. The data used in this report were generated from the EMSAS Fall Enrollment files, which are submitted to the Missouri Department of Higher Education (MDHE) each fall. Data included in EMSAS files were prepared in the admissions and registration offices at the respective campuses. The data are counts as of the census date at each campus, which is defined as the end of the fourth week of classes for the fall session. The source data are based on the reporting guidelines and definitions of the Missouri Department of Higher Education (MDHE) and the National Center for Educational Statistics (NCES).

In tables which include counts of on- and off-campus students, the columns titled “On-Campus”, according to the MDHE guidelines, include students enrolled geographically on campus and students in the Graduate Engineering (Residence) Centers. All other students are counted in the columns headed “Off-Campus”, which include students enrolled in extension courses and students that receive H.S advanced credit from the Kansas City and St. Louis campuses. The tables of the Table 2 series also include full-time equivalence (FTE) counts.

Definitions of FTE:

Undergraduate FTE = Total Student Credit Hours/15

Graduate FTE = Total Student Credit Hours/12

Dentistry FTE = Headcount

Law FTE = Total Student Credit Hours/15

UMC Medicine FTE = Headcount

UMKC Medicine FTE = Headcount

Optometry FTE = Headcount

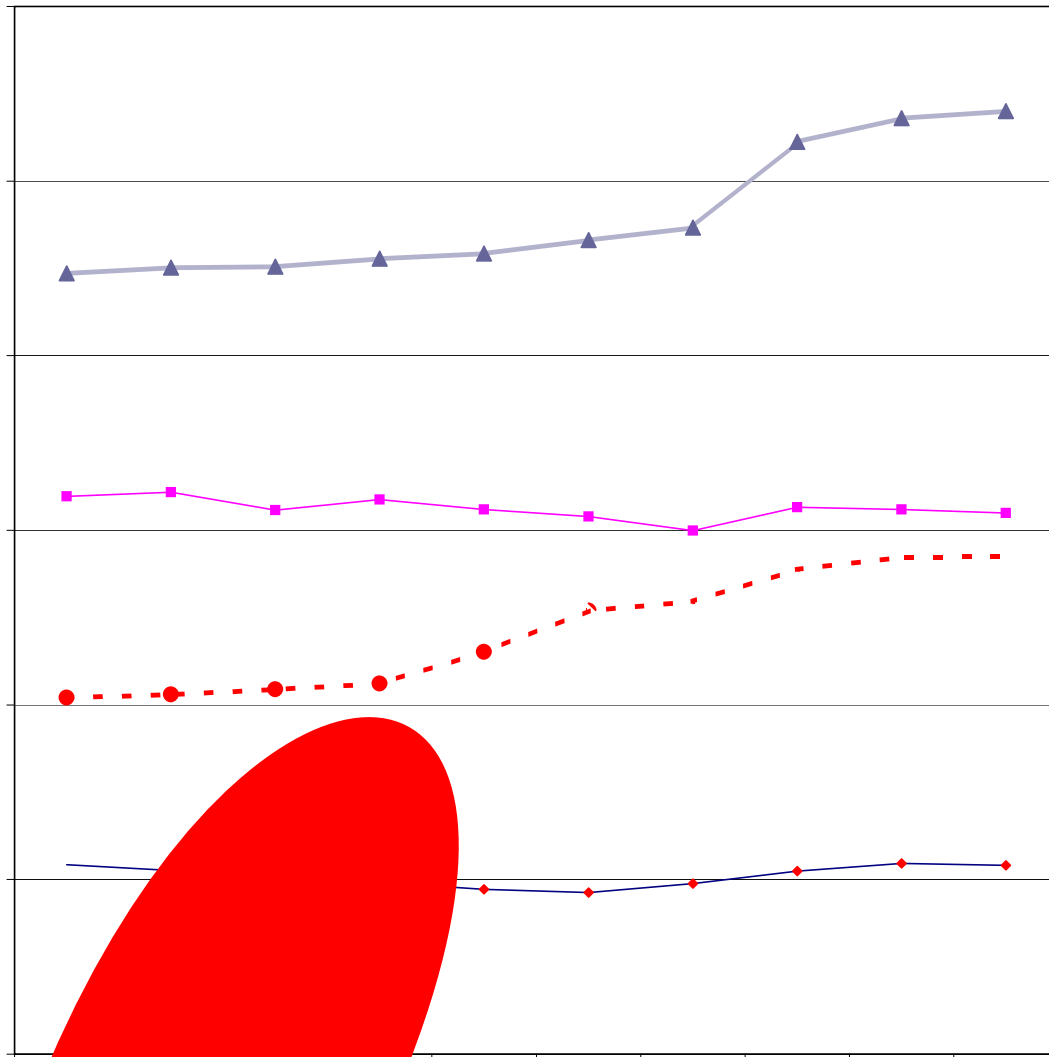
Pharmacy FTE = Headcount

Vet Medicine FTE = Headcount

Caveats

First- and second-year students in the Medicine MD program at UMKC are included in the undergraduate counts of the Table 2 and Table 3 series.

Enrollment counts for students in “Off-Schedule” courses, which include intersession courses, short courses, Video Credit courses, and other courses which begin and end on dates other than those for the regular academic semester, are accumulated during the term in which the courses began and are reported the semester following their end date.

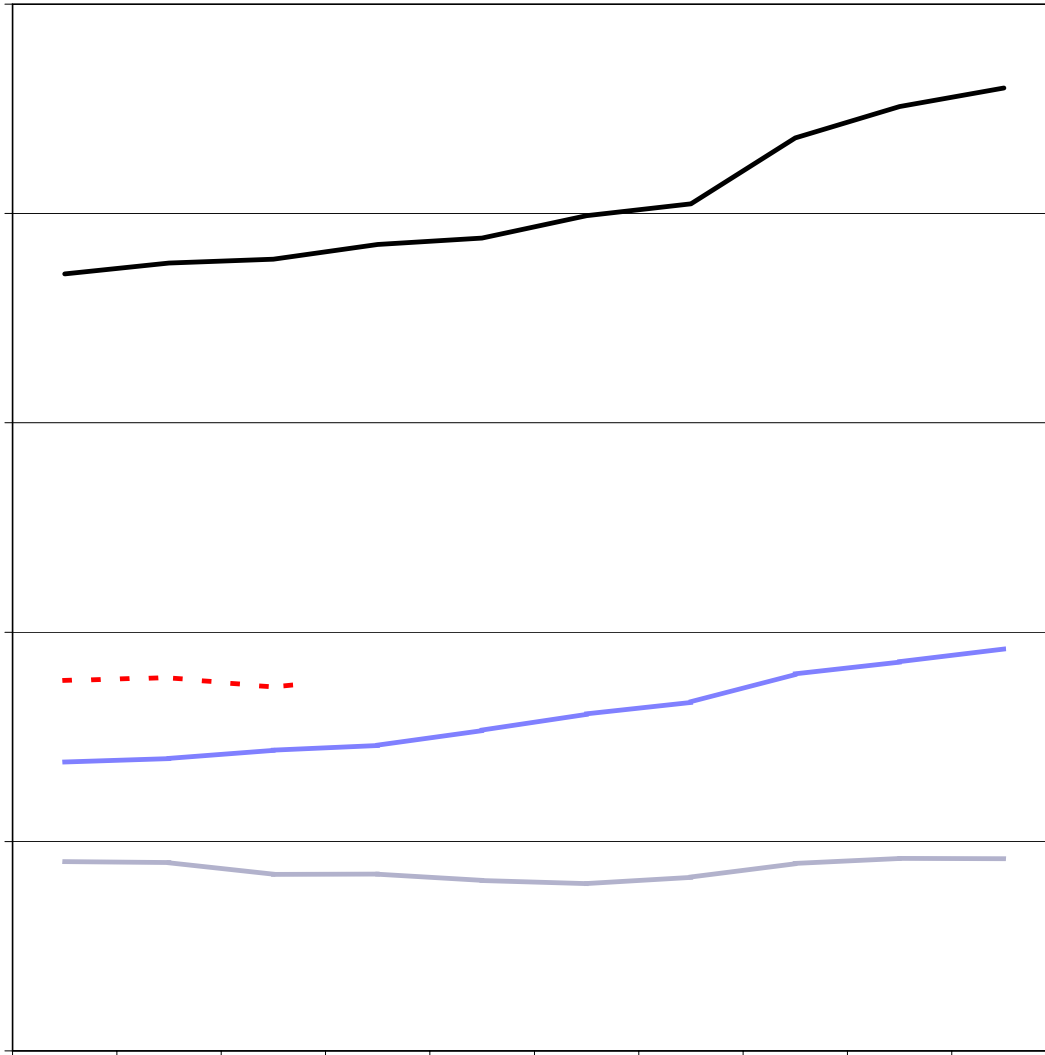
